Draft Minutes for Aug. 2 Picnic Attendance: Not taken. Speakers: Frank Francone / Colorado State Senate District 22 candidate, Tina Francone / Jefferson County Commissioner candidate, Janice Holmes / Foothills Parks and Recreation District candidate, Colin Larson / Colorado House of Representatives District 22 candidate, Ron Mitchell / Jefferson County School Board candidate, Sheriff Jeff Shrader / Jefferson County Sheriff's Department, Tony Sanchez / Colorado State Senate District 22 candidate, George Stern / Jefferson County Clerk and Recorder.

The picnic started at 6:30 p.m.

Diane Suchomel, Vice President, welcomed everyone.

Tonight's speakers are Frank Francone, Tina Francone, Janice Holmes, Colin Larson, Ron Mitchell, Sheriff Jeff Shrader, Tony Sanchez, and George Stern.

Ron Mitchell has been serving on the School Board for 2 years. His term expires in Nov. All 3 of the appointees are running again. Ron was a principal. He feels one of his accomplishments is that he helped change the mood of the Board. They have been discussing apprenticeships at meetings. He feels he still has a lot of work that he needs to do such as full day kindergarten and raise the pay for teachers.

Janice Holmes is representing Friends for Foothills Parks and Recreation District. She is supporting an increase of the mil levy. It has been 17 years since the last increase. The mil levy would help maintain and expand trails and parks including safety issues such as lighting, repairs, and handicap access. The levy would also fund programming and staffing. The mil levy would cost an average home \$10 per month.

Sheriff Jeff Shrader will be rerunning for his office in 2018. Staffing is doing good. They are at 97% of authorized staff and hope to be fully staffed in a few weeks. They will be opening a Regional Dispatch Center early in 2018. This should speed up call responses and be cheaper. He passed out a flyer, "Jefferson County SAFETY in FAITH Summit; Partners in Prevention." It is Aug. 17, 8:00 a.m. - 3:00 p.m. at the Jefferson County Fairgrounds.

George Stern is running for Jefferson County Clerk and Recorder. He lives in Golden. He was an attorney. He has a 4 1/2 month old puppy. The Clerk and Recorder position oversees 3 departments: Elections, DMV, and Marriage, Licensing, Recording, and Filing.

Colin Larson is running for Colorado House District 22. He owns Atlas Coffee. He is running because he feels

the government needs to run with more business sense. We have a lot of aging residents who want to age in place. He wants the government to be more accountable.

Tina Fracone is currently a RTD Director. She is running for County Commissioner. She is running for Don Rosier's position. He is term limited. She is a conservative Republican. She wants people to talk with her about what is being done right and what is being done wrong.

Frank Fracone is running for Colorado State Senate District 22. He is an independent Republican. He is running for Justin Everett's position. Justin is running for Colorado State Treasurer. Frank grew up in Denver. He worked in Entertainment Law in Los Angeles. He has noticed that when someone tries to change things, they get swarmed by special interests. He is for limited government, freedom, and free enterprise. He will vote the way he speaks.

Tony Sanchez is running for Colorado State Senate District 22. He asks "What kind of Colorado are we? Are we for Big Money Businesses? Or are we for the people?" People care about their community but they are losing their voice. He ran last election for Freedom of Education. He is on the Board of Colorado Union of Taxpayers (CUT). He wants transparency in education monies. Roads need to be fixed but we need to manage the money. His background is in Management. When we vote for money to go to something, it should go to it. Tony wants to serve our community.



From CKSII HOA Board Meeting Minutes from July 11, 2017 President, Jennifer Blake called the meeting to order at 7:00 pm. Board members Jennifer Blake, Debbie Opperman, Bob Pellegrini, Larry Opperman, Bob Haberkorn, and Robert Sudar) were in attendance along with Roger Borcharding of DARCO Property Management.

Treasurer's Report: Debbie reported the HOA currently has 338 members, of these, 238 are voluntary members and 100 are permanent members.

Management Report: Three inspections were conducted in June. Thirty violations were provided to homeowners. The violations included: 11 campers stored in view, 7 trailers stored in view, 3 boats stored in view, 2 homes with trash containers stored in view, 1 dead tree, 1 tree with limbs blocking sidewalk and stop sign, 3 basketball stand blocking sidewalk, 1 fence needing repairs, and 1 window covered with black plastic. No violations were referred to the HOA attorney and there are no violations outstanding with the HOA's attorney. In the last 30 days, there have been six home sales and five more homes are for sale.

ACC Committee: Bob Pelligrini reported 13 requests and 13 approved with 0 in pending status. Applications were as follows: 3 for paint, 2 for roofs, 2 for sheds, 2 for window replacement, 2 for fences, 1 for tree removal, and 1 for garage door replacement.

Welcome Committee: Jennifer Blake reported that the next round of deliveries would be coming up later in July. She also had thank you cards for the board to sign to send out to the businesses that donated to the welcome baskets.

Landscape Committee: Stephanie Haberkorn reported there are no real updates. They've just been dead-heading some of the displays.

Garage Sale Update: Jennifer reported that nearly 30 homes participated this year and she received a lot of positive feedback about it. Also, the large item pick up went much smoother this year.

Social Committee: Jennifer reported that: the committee met on June 20th to discuss the holiday hayride and held a discussion about adding a new social event in the late summer or early fall. The board heard that they might need extra funds in excess of the budget amount for the combined costs of the possible summer activity and the holiday hayride. The board was fine with that as these are a great way to foster more involvement within the community.

Updates: Jennifer reported that the NextDoor site is up to 402 neighbors, with 55% of households participating.

New Business: It was brought to the board's attention that a listing agent for a home is citing the HOA membership incorrectly as optional. They were notified and the agent's company was notified as well. * Jennifer also raised the idea about new sign stands to notify the neighborhood of meetings and events, etc. Larry will look into options as the current ones are old metal sign frames that do not hold the information very well any more.

The meeting was adjourned at 7:35 pm.

From A Moment With The Board The July 12th monthly meeting was attended by Officers/Board members and a few residents. Our monthly meeting was held at the pool pavilion, starting at 6:30p. Our Dumpster Chair gave us some pretty impressive event numbers to share. There was 107 trips made into the Dumpster Event by CW neighbors in 4 hours of operation. There was 3,000 lbs of document shredding, 5,080 lbs of metal collected in the roll-off and 38,660 lbs of trash compacted in 4 loads of the trash trucks. Amongst all of the noise, traffic and unloading of vehicles we had 22 volunteers making sure the event came together. The registration table received 31 payments at the event and 9 new residents became members. The Dumpster Survey was answered by 77 attendees and a few questions were written in for our review. Look for articles detailing the questions and answers from CWCA.

Currently we have 374 memberships and the 2017 CWCA Budget based on 345 memberships. Memberships are im-

portant to keep all of the scheduled events happening without disruption. The common entrances on Zephyr, Yukon & Webster are being freshened up with new mulch and plants. Watch for opportunities to lend a hand on these projects. The pool evenings have come and gone for this year. We hope those of you who did get a chance to venture over for the evenings had a good time. August 1st will bring back the National Night Out event to be held at the pool pavilion. The August monthly meeting will be our last meeting held at the pool pavilion, so when school resumes we will head back over to Dutch Creek Elementary and the meeting will start at 7p. From Leawood Civic Association Minutes July 11, 2017 Board Members Present: Paul O'Connor, Richard White, Chip and Angela Langowski, Rhonda Eveleth, and Debby Baker.

Treasurer's Report – Richard presented the Treasurer's Report, which included LCA current account balances, payments received and bills paid. Residents have donated more money to the Scholarship Account.

Leawood Annual Picnic, August 26th - The cost for picnic goers will be increased by \$1.00. The cost for members will be \$5.00 and \$6.00 for non-members. Children 3 and under and adults 75 and above will remain free. Paul will look into other possible food caterers. The board will need volunteer help to set-up the picnic. Set-up will begin between 8:30 and 9:00 AM. Debby will look at member registrations for residents that indicated a willingness to help.

LCA Post Office Box - The Post Office has requested a Board Resolution stating the names of Board Members who are authorized to access the PO Box. It was the decision of the Board that all Board Members be included as authorized users. Debby will create the document and circulate to all Board Members for a signature.

Jay Court Entrance - Because there are only 7 Board Members, it has been difficult to maintain the entrances this summer. The Board discussed hiring someone to do the landscaping and maintenance or possibly resident volunteers.

Richard asked for suggestions as to what landscaping should be done. Weeding, mowing, planting flowers and adding bark were discussed. Debby will contact resident Jennifer Dawe to ask if she would be able to assist in planning for the entrance.

The Board agreed that both the east and west sides of the entrance need to be addressed.

From Leawood Metropolitan Recreation and Park District Minutes July 12, 2017 The meeting was called to order at 6:34 PM at Leawood Park by President Kyle Sargent. Members present were: Directors Donna Snyder/ Treasurer, Debby Baker/Special Projects, Jennifer Dawe, Linda Smith/ Secretary VP and Dave Padilla, Parks Manager. Resident Reggie Bland was also in attendance.

Public Comment/Correspondence - Resident Reggie Bland came to the meeting to ask about the height of the weeds in the parks and what we were doing about it; and to suggest we install a Frisbee golf activity in Weaver Park in some of the vast open space. Dave answered the situation on the height of the weeds/grass in Weaver Park, Kendall and Raccoon Park. We have a landscape contract with Weston Landscaping with a certain amount of bluegrass cuttings and a certain amount of native grass cuttings. Weston comes in every Monday as contracted to cut the bluegrass. Cuttings for the native grass in Weaver and Raccoon are set at three or four (depending on need) times a year. This year we have used all but one of the cuttings for Weaver and Raccoon due to the excessive growth from snow and rains in May. According to Weston they have had severe labor problems and were unable to meet our request for a spring weed spraying. The combination of the wet weather and hot temperatures this season with the other factors has caused this situation over the past several weeks. We understand that the labor crunch is true with most landscapers this year, and it has had an impact on other park projects. Dave is continuing to outreach to vendors who can commit to weed spraying. As of the meeting, we have been told the parks will be cut on July 15. We understand your concerns and thank you for bearing with us.

Mr. Bland asked about a Frisbee golf course. Various members discussed some of the previous requests by residents (including a Frisbee golf course), and the factors that the board has to consider for any such use of the parks, which include safety, parking, and impacts on usage. We will look into the option if there is enough interest.

Treasurer's Report – Donna presented the Treasurer's Report. We continue to receive property tax and ownership tax revenue and are a little more than halfway to our projected budget on property taxes. These funds trickle in as late as November. We also received funds from Colorado Lottery. Invoices for the month include: Weston for landscaping services, United Site Services (port-a-potties), Denver Water, Waste Management, Xcel, Horizon for irrigation supplies, DBC for supplies, Recreation Plus for repair to kids rocker ride in Leawood Park, Dave's invoice and reimbursement to petty cash. Linda moved the Treasurer's report be received and bills paid. Debby seconded and the motion passed unanimously.

Parks Manager Report –Repairs were made to several irrigation lines and clocks. Thank you to residents who pick up after their dogs. However, we have a hard time keeping bags in the holders from week to week. We would appreciate that you take only one or two for your walks. Our budget for doggie bags has tripled in the past few years. We have a lot of non-resident people using this service also. Weston is having some issues with labor and with ensuring that their

BEHIND the BADGE by Sheriff Jeff Shrader It feels like summer just began, but the start of another school year is right around the corner. It's time to purchase school books, pencils and pens, and backpacks. On the list may also be a new computer, laptop, or tablet. As students get back into the swing of doing homework and aiming for high grades, the Sheriff's Office recommends they also take precautions to thwart malware and phishing schemes by practicing safe technology usage.

Malicious cyber activity affects students in a variety of ways, ranging from scams to cyber bullying. Fortunately, there are five simple steps you can take to keep you, your kids, and your devices protected from the latest threats.

Keep software up-to-date. Be sure to keep the operating system, browser software, and apps fully updated with patches. Even new machines can have out-of-date software that leaves you at risk. Operating systems and applications are constantly being updated to fix bugs and address security issues. You should use automatic updates to ensure you're using the most secure version of the software that is available. Also, review the privacy settings - when an app is updated, it may change your settings.

Malware Protection. Make sure to have antivirus and anti-phishing support installed on all devices (desktops, laptops, tablets, etc.). Set it to update automatically and run virus scans at least once a week. Since malware today is increasingly sophisticated and can avoid detection by antivirus software, also consider installing script-blocking and/or ad-blocking browser plugins.

Practice Safe App Usage. Use trusted apps and only browse trusted websites. Malware is often hidden in apps that trick you into downloading them or in fake websites that lure you in with interesting pictures or stories.

Be a Smart Network User. Don't access personal or financial information over unsecured public WiFi networks such as the free WiFi in coffee shops, bookstores, hotels, and schools, as this data can be easily 'sniffed' (a.k.a viewed) by others. Instead, consider using your smartphone's more secure cellular signal to surf the Web, and if you have other devices, 'tether' them to your phone instead of using an open and unsecured WiFi.

Be on Guard for Phishing. Don't open email attachments from untrusted sources. You may be expecting emails from group members or teachers, but use caution when opening any attachments. If you are not expecting an email or it just doesn't look right, don't open it. It could be a phishing attempt.

From Jeffco Website Fuelwood Sale Expected Winter of 2017 Jeffco Open Space often has fuelwood to sell to the public at the end of the summer. This wood comes from forestry projects including removing dead or diseased trees or thinning for forest health. Harvested wood is first used for structures within Open Space parks such as picnic shelters, picnic tables, buck-and-rail fences, or other projects. Any wood in excess is then made available to the public.

This year, Jeffco Open Space is facilitating work with the Coalition of the Upper South Platte and the Upper South Platte Partnership on approximately 40 acres of forestry work at Conifer's Community Park at Beaver Ranch. The wood from this forestry work will be available for sale as fuelwood in November or December 2017. Those interested should be aware that the wood will be very green, heavy, and sap-laden and will not be ready to burn this winter. The amount of wood will be more than in past years, allowing it to be sold over several weekends.

Jeffco Open Space will announce when the fuelwood is available and ready for sale later in the year.

Jeffco Open Space was founded as a land conservation organization in 1972. Our mission is to preserve open space and parkland, protect park and natural resources, and provide healthy, nature-based experiences. Funded with a one-half of one percent sales tax, our organization contributes to city and park district projects, has preserved more than 54,000 acres, and manages 29 open space parks and more than 236 miles of trails in Jefferson County, Colorado.
