Draft Minutes for June 2 Meeting: Attendance: Diane Suchomel / At Large, Ray Moore / At Large, Cheri Paavola / At Large, Judy Alliprandine / Columbine Knolls, Tom Majcen / Columbine Knolls South Estates, Al Hintz / Kipling Hills, Maureen Sielaff / At Large, Colin Insley & Sean Kitners / Foothills Parks & Recreation District.

The meeting started at 6:30 p.m.

Diane Suchomel, Vice President, welcomed everyone.

No one from Jefferson County Sheriff's Department was present. There have been lots of vehicle trespass, stealing vehicles, and cutting off catalytic converters.

No one from Jefferson County Public Schools was present.

Tonight's speakers were **Colin Insley and Sean Kitners from Foothills Parks & Recreation District.**

Colin said that Jefferson County is at level clear. Inside the Foothills Parks and Recreation District facility, masks are optional.

Last year the mil levy conversion passed.

Clement Park will have 10 pickle ball courts and 3 tennis courts. They hope to start on the Pickle ball courts in late Aug. and finish by Oct. or Nov. The pools at 6th Ave. and I-70 and Columbine West were built in 1974. Plans are being drawn up to redo them. There will be a completely new facility for the Foothills Club House. Construction will start next year.

They will work on the baseball / softballs fields across from Walmart at Bowles and C-470. They plan to build out the Dutch Creek trail to C-470; hopefully with some grants. They will continue upgrading LED lights, boilers, and rooftop projects recommended by the Energy Service Contract last year.

Sean Kitners handed out the Mil Levy hand-out from last year.

In 2021 they will be working on Lakehurst Park, Westfield Park, Clement Park, Eastern Regional Park, Westbury Greenbelt, The Ridge, Victory Park, and Columbine Hills / Sports Park. In 2022 they will be working on Jim Hoida Park, Lakehurst West Park, Westbury Park, Columbine West Park, West Laurel Park, and Willow Creek Park. The details are very sketchy at this point. They all need irrigation repairs. They will work on play ground equipment on Westbury and Willow Creek Parks.

The fishing pier at Hine Lake was a Capstone Project. Senior students from the School of Mines worked on it. They analyzed the failures at the north end of the lake and where improvements were needed. The new pier will be on floats so it moves based on the water level while maintaining ADA access. They are working on a fishing line recycling project with Eagle Scouts. They recently stocked the lake with rainbow trout. They will also address parking. Sarah McAfee works

with the Eagle Scouts and volunteers. The volunteers can be from the community, churches, or schools.

They are working on a splash park at The Ridge.

They are actively working on 3 of the parks. Woodmar is too wet to start right now.

Will the matching funds project be reinstated with local HOAs? Not yet. But if you have something, call Colin.

At Clement Park, there will be 8 community concerts. There will NOT be a Red, White, and You or Shakespeare this year.

They will have 2 part time rangers. One will cover all of the neighborhood parks. The other will be for Clement Park.

They are also looking for Maintenance positions. The age range starts at 18. Some positions are yearly. Some are just part time. They also need aquatics / life guards. The age range starts at 15. You can get more information on their Web-site.

They have had one project from Sept. 2021 that has been cancelled several times due to COVID-19.

If you are interested in getting their monthly E-Newsletter, sign up on their website.

Because of COVID-19, their budget is in shambles. The golf dues saved them.

Reports from Officers We do not have a President.

Roll Call was taken. We had 7 members present and had a quorum.

Ray Moore, Treasurer, said that we have \$1,614.01. Ray reminded everyone that we will not charge a fee this year.

Cheri Paavola, Secretary, was present. The minutes for May were passed.

Diane Suchomel, Vice President, was present.

20-123513 RZ 9155 W. Fairview Dr. It is at Garrison and Fairview. They want to rezone from C1 to residential for a 55 unit multi-family residential project.

21-119596 RZ 5808 S. Swadley Street. It is near Simms and Bowles. It is a 10,000 sq. ft. 1 story building for daycare / preschool.

21-118446 SA Powderhorn Elementary wants to remove 9 temporary structures. They want to build a 9,000 sq. ft. building and remodel the school.

21-118209 PA is for 13412 W. Coal Mine. They want to modify the PD for a 9,00 sq. ft. storage and 25,000 sq. ft. U Haul facility. They want to keep the existing building.

21-111382 SD S Alkire and W. Bowles. They want to build a senior (55+) living, 88 units, . It is called Highland Trails. There has been 1 application so far for Fireworks (update: now 11 permit applications for fireworks stands in south Jeffco area.)

There is zoom meeting for the new library in South Jefferson county on June 15 from 5:30 - 7:30. It is in their 5 year master plan. There is no site chosen yet.

The Jefferson County Sheriff's on-line crime mapping was removed on April 14. They are working on contract negotiation. (update: as of 6/13/21 no replacement yet for public crime mapping application.)

Legislature

SB 21-062 was withdrawn. It is about limiting law enforcement. It was replaced by 21-273. (update: 21-273 wasn't voted out of committee and wasn't passed this legislative session.)

HB 21-1310 is about rules HOAs are allowed to have/enforce about flags and signs on homeowners' property. They can limit size and location, but not subject matter. (Update: the State Legislature passed this amended bill. It was sent to the Governor for signature. No decision on it by the Gov. yet.)

HB 21-1229 is 27 pages long. There were numerous changes. It is about HOA governance, funding, recording keeping, etc. Part of it is that HOAs can't ban artificial turf or renewable energy. Also if you ask the HOA for a document, it must be delivered within 30 days or a financial penalty will be assessed if they aren't delivered within the required time period.

SB 21-249 is about Keep Colorado Wild Annual Pass. Unless you opt out, you will be charged for the pass when you renew your vehicle registration . Sneaky!

A number of the firearm bills have been postponed indefinitely.... and some of them were passed and signed into law. Watering restrictions are from May 1 through Oct. Watering is not allowed between 10 am and 6 pm. and not supposed to water more than 3 days/week

Commander Swavely was supposed to take over on June 1--- but that has changed. The new Commander in charge of Patrol at South Precinct will take over later in June.

Our net meeting is Wed., 7/7, at 6:30 pm in the Powderhorn Park. We are still checking on rooms.

Old Business The position of President for COHOPE is still open.

New Business Pine tree infestations have been found in the area. It starts with brown needles on top of tree and works way down through tree. It kills the tree in 1 growing season. If you want to see an example, go to Westbury park. Diane's HOA recently had all pine trees sprayed.

I would suggest lightly stepping on your cover to test it. Please contact the HOA at cksii.info@gmail.com if you would like us to connect you with this homeowner who graciously agreed to provide information on where you can get a replacement cover and its associated parts. Unfortunately, all costs associated with this repair fall on the homeowner and not the county or water company, we checked. Again, this was hopefully an isolated incident, but worth

checking.

In closing, we are hopeful we can soon hold our HOA meetings in-person. I have never held an in-person board /members meeting since becoming president in January of 2020 (thank you pandemic and thank you Zoom), so I'm excited for that possibility. From Leawood Metropolitan Recreation and Park District Minutes May 12, 2021 The meeting was called to order at 5:35 p.m. by President Steve Wall. Members present: Debby Baker/Vice President and Secretary, Donna Snyder /Treasurer, Ike Nelson/Board Member, Wade Hancey/Special Projects, and Dave Padilla/Parks Manager.

PUBLIC COMMENTS 1. Received numerous notifications about a deceased animal in Raccoon Hollar. Board Response: Dave handled it immediately. 2. Tom Bryant reported that the airborne bugs in Raccoon Hollar are worse than usual. Board Response: The airborne bugs are called gnats. Most often they fly in large numbers like clouds and can be very annoying. The bugs are worse this year because of all the moisture that we have received. The bugs hatch in the creek and remain close to the water. There is nothing we can do as we are prohibited from spraying the water or along the

banks. The gnats are most active around dusk. To avoid the nuisance, try to time your activities at an earlier or later time. 3. Received multiple notifications regarding the debris in the creek in Raccoon Hollow. Board Response: Urban Drainage has been notified of the issue. 4. A Leawood resident reported that the lights were out at the Weaver Park Pavilion. Board Response: Dave investigated and found that the electrical box had been vandalized and the power turned off. Dave repaired the box and turned the power back on.

Treasurer's Report - Donna presented the Treasurer's Report, bills paid this month include Denver Water, doggie bag vendor, Waste Management, Xcel Energy, Liberty Waste Management, United Site Services (final bill), Weston, Recreation Systems (repair of swing in Leawood Park), Rich Alarcon, Dave's invoice, and reimbursement to petty cash. Debby moved that the Treasurer Report be received, and bills paid. Ike seconded and the motion passed unanimously.

Parks Manager Report - Snow removed in all Parks. All parks were mowed, inspected, and doggie bags checked and replenished as needed. 1. Weaver Park: A large branch broke from a tree by the tennis courts. The debris has been cleaned up. The electrical box at the pavilion was vandalized. It has been repaired. 2. Raccoon Hollow: The tree trimming project continues. The rain and snow have delayed progress but will restart as weather conditions permit.

OLD BUSINESS 1. Website: The addition of the Park District to the LCA website is nearing completion. There are still a few adjustments and corrections to be made, but overall is looking good. The URL is leawoodmetrorecparkdistrict.org. 2. Weaver Park Bridge repair: We must receive a Minor Flood Plain Permit before the work can begin. 3. Acrylic overlay and Pickleball striping at tennis court: After reviewing the requirements and cost estimates, the Board agreed to authorize Wade to move forward with the negotiation of a cost-effective contract.

NEW BUSINESS 1. Electric vehicles in the parks - Tabled until next meeting due to time constraints. 2. Graffiti in Weaver Park - Tabled until next meeting due to time constraints. 3. Disk Golf in Kendall Park - More research is needed before a decision can be made. The projected 2021 park project list was updated to include the additions to the Weaver tennis court and disk golf in Kendall Park.

Jefferson County Seeks Resident Feedback—With a light finally at the end of the long tunnel that is the COVID-19 pandemic, Jefferson County is setting its sights on the future, as well as on pandemic recovery needs for communities. Jefferson County Government is seeking input from Jeffco residents to collect data and help steer these efforts through two distinct surveys: the Jefferson County Community Needs Survey ("Community Needs Survey") and the Jefferson County Community Health and Well-being Survey ("Community Health/Well-being Survey").

The Community Health/Well-being Survey will be made available at the same time as the Community Needs Survey but will serve a distinctly different purpose. In addition to assessing the community health impacts of COVID-19, this survey will address cessation and receptivity to best practice tobacco control policies, substance use and mental health, food insecurity, community connectedness, and priority community health needs. The results from the survey will help shape Jefferson County Public Health's future programming and will be used to determine community awareness of, and support for, best-practice community health policies.

These surveys will be running from June 1, 2021, through July 12, 2021, and residents of Jefferson County are encouraged to complete both surveys. The Community Needs Assessment Survey is available to anyone living or working in Jefferson County through an online platform at www.jeffcocovidsurvey.com, and is available in both English and Spanish on that site. Take the Community Health/Well-being Survey in English or take the Community Health/Well-being Survey in Spanish. It is available to anyone living in Jefferson County.
