The meeting started at 6:00 p.m.

Diane Suchomel, Vice President, welcomed everyone.
No one from **Jefferson County Sheriff's Department** was present.
No one from **Jefferson County Public Schools** was present.
No one from **Foothills Parks and Recreation District** was present.
We did not have a speaker for the night.

Reports from Officers We do not have a President.
Roll Call was taken. We had 5 members present and had a quorum.
Ray Moore, Treasurer, said that we have \$1200.74.
Cheri Paavola, Secretary, was present. The minutes for June were passed.
Diane Suchomel, Vice President, was present.

Community Meeting: 22-114002 is for 6659 S Harlan St. It is for a rezone. PD for 8 detached homes.
Administrative Exception: 22-117118 is for 6634 S Field St (in Woodmar Village). It is a renewal to allow an exception for a home occupied large day care (0-12 children) in a PD.
Pre-application: 22-113881 is for 8015 W Bowles Ave (Bowles Crossing shopping Center). It is a Site Development Plan for Vectra Bank. It will be 1 story, 3554 sq ft.
22-113981 is for 13874 W Bowles Pl. It is a Site Development Plan for medical office bldg. It is west of C470 and south of W Bowles Ave.
22-114376 is for 5067 S Eldridge St. It is for a rezone for 10 unit/duplex development.
20-122769 is the 3rd referral for 9700 Old Coal Mine Ave. It is a Preliminary / Final Plat. This time it is a new developer: Peak Development, LLC. Richmond Homes dropped out of the project. The latest version: is for 52 single family attached homes and 53 single family detached homes. So a total of 105 units. They want an exception for the noise level allowed from adjacent public street traffic. It is higher than allowed inside the subdivision. The cell tower will stay where it is and be disguised as a clock tower. Previous developer had requested and received exceptions for landscaping requirements along W Bowles Ave and for spacing of intersections of the private roads within the subdivision. The previous developer had requested that exception and the new developer is also asking for that exception. The fire depart-

ment raised a concern about fire truck access on the internal private streets during a previous referral of their plan. To address that situation...If the turning radius of a street or cul-de-sac is inadequate for a fire engine to navigate and the building is 30 ft. or higher, then the building must have a sprinkler system.

Registered Distressed property: At 6650 W Coal Mine Ave, the former McDonald's site. There is trash, junk debris, and property not secured.

Short Term Rental: There was a virtual meeting to discuss the public's opinions. There were software caused issues (phone callers could not access chat rooms). They expected over 300 participants, but only started out with 38. There were 41 at the end. They had an Introduction. There are currently 17 places permitted for short term rentals with 756 listed. They are collecting opinions and ideas on how to make the process better so that more people will register. Currently they only investigate a rental if there are problems reported. They had a survey earlier in the year with 1400 responders. Of those 43% did not want any form of short term rental allowed. They encourage people to send any comments in. They don't know when new regulations will be implemented. They want to make the process easier. Our group would like them to require a notarized letter from the HOA saying that it is allowed and want a phone number where the owner can be contacted if there is an issue. The path forward is to get more feedback on str, draft regulations, and then have a planning commission and BOCC hearing. There is no timeframe for any of these.

Do they currently require notification of police and fire of the presence of renters and how to contact them? No.

New State Laws: HB 22-1151 Turf replacement plan. The Colorado Water Conservation board has until 7/1/23 to develop the plan to encourage people to voluntarily replace irrigated lawns with water-conserving landscaping in common areas. Eligible entities will be able to apply for matching. HOAs and non-profits are eligible, but there is only \$2M available. Read the final version of the bill on the State Legislature's website.

HB 22-1314 is a 28-page bill governing towing from private properties. It includes common interest communities. Read the final version of the bill on the State Legislature's website for details.

HB 22-1137 sets limits on Home Owners Associations. These include foreclosures, fines, notification of violations, etc. Read the final version of the bill on the State Legislature's website.

Information from JCSO on the results of hotline for reporting illegal fireworks: 257 dispatched calls, 135 self initiated calls, 23 summons issued. 488 pounds of fireworks confiscated.

The August meeting will be at the Columbine Library. Speakers will be Commissioner Leslie Dahlkemper and Dan Conway, Strategy & Budget Director. The title of their presentation will be: Jefferson County Funding Challenges.

Chris Reynolds mentioned in last month's newsletter that we are working on replacing the monument signs at the S Yukon Way and W Chatfield Ave entrance. We received an initial design from one of the two sign companies we are working with, but unfortunately that design was not well-received by the board. We recently provided the graphic designer we have on retainer some inspirational images of sign concepts we like, and we are now awaiting the next round of designs. It is vitally important to the board we select a sign that we can all be proud of for many years to come. I'll keep you posted.

You may have seen in the media recently about a few HOA's in Colorado that were foreclosing on homes for failure to pay assessments/dues and/or violations. In my opinion, this is a serious overreach by these HOA's, and fortunately our governing documents do not allow our HOA to take such drastic steps. That said, this issue, among others, prompted legislation to be enacted at the state level. Governor Polis signed HB 22-1137 on June 3, 2022. The new laws become effective on August 10, 2022. This legislation will impact all HOA's, some significantly, and some not so much. We believe the new legislation will have a minimal impact on our HOA because we have low annual dues and rarely have delinquencies, but it will require a careful review by your board, our property management company, and our attorney to ensure we are following the new legislation. Our board received some initial guidance from our attorney (Orten Cavanagh Holmes & Hunt, LLC), it which they said "Changes as a result of HB 22-1137 may supersede numerous provisions of existing governing documents, particularly with respect to non-payment of assessments and enforcement. The practical implications of HB 22-1137 remain uncertain. However, homeowners, boards of directors, and managers should anticipate significantly increased costs directly and indirectly related to these changes." I will keep your informed as we learn more about how this legislation will impact our HOA in terms of policy changes and costs associated with same.
